

Conservation Sub-Committee Report for 2020

There are now more than 90 species or subspecies of birds in the Hunter Region that are listed as threatened under either State or Commonwealth threatened species legislation. Further, those habitats that provide home for a diversity of currently non-threatened bird species are also under threat; thus, the conservation arm of the Club remains vitally important. No new species were added to the threatened species legislation during 2020.

Although the Club's concerns mainly revolved around the loss of habitat through various planned developments, submissions were also made to the Review of the Environment Protection and Biodiversity Conservation Act 1999 and the Draft Strategic Plan for Crown Land. The outcomes from these reviews will be of utmost importance to the future of bird species and their habitat.

A sub-committee was formed in 2020 to deal with the ever-increasing number of conservation issues. Members were Ann Lindsey (co-ordinator), Bob and Margaret Stewart and Tom Kendall, with Mick Roderick in an advisory capacity.
